I FURTHER AGREE that as a participant in any riding instruction or equine activity at ROCKING L EQUINE, I am solely and totally liable for any loss, injury, death or damage of any kind or nature to my horse, to my equipment, to any horse or equipment provided to me or my family or my guests, as well as any loss, injury, death or damage of any kind or nature to myself or any member of my family or to my guests as a result of any such riding instruction or equine activity.

I FURTHER AGREE that I will indemnify and hold harmless MIRANDA KADEL, BLAKE KADEL & ROCKING L EQUINE, as well as any employee or agents thereof and all premises' owners of ROCKING L EQUINE as well as all neighboring or adjoining property owners from any injury, loss, death or damage which my horse or any horse provided to me or any equine activity may cause to myself, to others, or to the property of myself or others.

I FURTHER DECLARE AND AGREE that I have had the opportunity to purchase any liability insurance to cover all property, horses, persons and activities covered by or anticipated by this RELEASE AND AGREEMENT.

I FURTHER DECLARE AND AGREE that the entering into this RELEASE AND AGREEMENT is necessary in further consideration of the participation in and provision of riding instruction, horses or equine related activity or equipment by MIRANDA KADEL & BLAKE KADEL , individually, and doing business as ROCKING L EQUINE and for the price and term agreed to for those instructions, equipment and services.

WARNING

Under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

The risks of equine activities include, but are <u>not</u> limited to the following:

- 1. The propensity of an equine, which includes horses, ponies, mules or donkeys to behave in ways that may result in injury, death or damage to the persons on or around them or to property;
- 2. The propensity of an equine to be unpredictable in its reaction to sounds, persons, sudden or unfamiliar movement, as well as unfamiliar objects, persons or other animals, or other things, including its owner, renter, boarder or rider;
- 3. The possibility of an equine to encounter the hazards of weather, surface or subsurface conditions that could result in injury, death or damage to the persons on or around them or to property;
- 4. The possibility of an equine colliding with other equines, animals, persons or objects that could result in injury, death or damage to the persons on or around them or to property; and
- 5. The potential of the owner, renter, boarder, rider or other participant to act in a negligent manner, either foreseen or unforeseen, that may contribute to injury, death or damage to others or their property, such as, but not limited to, failing to maintain control over the equine or not acting within his or her ability.

THIS RELEASE AND AGREEMENT shall remain valid until expressly revoked in writing by the undersigned and hand-delivered to MIRANDA KADEL & BLAKE KADEL. I acknowledge that I, my family and my guests, have received instruction on the proper use of all equipment and animals which may be involved in all equine activity or related activity.

I FURTHER ACKNOWLEDGE that on behalf of the below-designated minors that I am the parent and/or legal guardian of the minor, and that I am legally responsible for each. That I further agree to release, discharge, indemnify and hold harmlessMIRANDA KADEL, BLAKE KADEL & ROCKING L EQUINE as well as any employee or agent thereof and all premises owners of ROCKING L EQUINE as well as all neighboring or adjoining property owners for any injury, loss, death or damage incurred or sustained by any of the below-designated minors or caused by any of the below-designated minors at any time while engaged in or present during any equine activity or related activity or riding instruction while on the premises of MIRANDA KADEL, BLAKE KADEL, ROCKING L EQUINE or any neighboring or adjoining property.
