Until you have completed this COVID-19 Waiver and Release, you may not participate in any Storybook Equestrian, LLC or Covered Bridge Farm event, enter or have access to any building or horse located at Storybook Equestrian, LLC or Covered Bridge Farm.

Prohibition of access will not abate any costs charged by Storybook Equestrian, LLC and Covered Bridge Farm.

I waive, release and forever discharge Storybook Equestrian, LLC and Covered Bridge Farm, its managers, members, officers, employees contractors, successors and assigns from any and all actions, claims, causes of action, demands liability suit, and expense including without limitation attorneys' fees that may arise or are associated with or result from either my, or any of my family members or any third party contracting COVID-19. I agree not to sue Storybook Equestrian, LLC and Covered Bridge Farm as a result of either me, any of my family members or any third party contracting COVID-19.

I expressly agree to indemnify and hold Storybook Equestrian, LLC and Covered Bridge Farm, and its managers, members, officers, employees contractors, successors and assigns harmless against any and all claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise from injuries or damages sustained by me as a direct or proximate result of my participation in Storybook Equestrian, LLC and Covered Bridge Farm activities or on Storybook Equestrian, LLC and Covered Bridge Farm property.

## Horse Show Stay Safe Protocol

- Employees will wear masks and/or face shields,
- Pre-entries are required.
- New additional releases will need to be signed by all participants.
- Only one person will be permitted in the show office at a time.
- Disinfectant will be provided at the in gate of the showing arenas.
- One non-equine professional per exhibitor is permitted to attend the event
- There will be no gathering of spectators.
- Each exhibitor and their guest (1) should limit their presence at the horse show to their schooling and showing time. Loitering is not recommended or permitted. This includes trailer parking.
- Everyone not mounted is required to wear a mask or shield.
- In the event of a storm you will be asked to shelter in your car.
- No congregating at any time or anywhere on the grounds.
- All awards will be made available at or near the show office.
- Assigned schooling times may be posted & must be followed if posted.
- There may be a posted order of go.
- If a COVID-19 incident or outbreak should occur, all competition staff, service
- providers, participants, and support personnel will be notified.
- The following individuals are not allowed to enter the competition grounds:
  - Anyone who exhibits COVID-19 symptoms,
  - Anyone who has tested positive for COVID-19 within last two weeks,
  - Anyone who has tested positive outside of the past 10 days, but is still symptomatic, or
  - Anyone who has been in close contact with someone who has tested positive for COVID-19 within the last two weeks 14 days. (Exception: Healthcare personnel who have treated patients using appropriate medical grade PPE during the course of performing professional duties are exempted from this restriction.)
- Any individual not in compliance with these regulations will be asked to leave the grounds & not return.
- Management reserves the right to change any rules or protocol at any time deemed necessary.
