THE UNDERSIGNED VISITOR ("VISITOR") IS AWARE, AND IS HEREBY ALSO PUT ON NOTICE, THAT BEING AROUND AND PARTICIPATING IN EQUESTRIAN ACTIVITIES IS HAZARDOUS AND CONSIDERED EXTREMELY DANGEROUS.

THE VISITOR IS VOLUNTARILY AROUND AND PARTICIPATING IN EQUESTRIAN ACTIVITIES AT GLENWOOD FARMS LLC, WITH FULL KNOWLEDGE OF THE RISKS AND DANGERS INVOLVED.

VISITOR HEREBY AGREES TO FULLY ASSUME ANY AND ALL RISK OF INJURY TO, OR DEATH OF, VISITOR and/or VISITOR'S HORSE(s) IN ORDER TO BE AROUND AND PARTICIPATE IN EQUESTRIAN ACTIVITIES ON ALL PROPERTIES WHICH MAKE UP GLENWOOD FARMS LLC.

VISITOR FURTHER AGREES TO HOLD HARMLESS GLENWOOD FARMS LLC, ITS OWNERS, MANAGERS, EMPLOYEES, AND VOLUNTEERS (collectively "GLENWOOD") FROM ANY AND ALL LIABILITY ARISING FROM ANY CLAIM WHATSOEVER THAT MAY BE BROUGHT BY VISITOR AGAINST GLENWOOD.

"HOLD HARMLESS" MEANS VISITOR AGREES TO FINANCIALLY PROTECT GLENWOOD FROM LOSS OR LIABILITY FOR ANY CLAIMS OR ACTIONS COVERED UNDER THIS AGREEMENT.

VISITOR FURTHER AGREES TO HOLD HARMLESS GLENWOOD FROM ANY AND ALL LIABILITY ARISING FROM ANY THIRD-PARTY CLAIM WHATSOEVER THAT MAY BE BROUGHT AGAINST VISITOR and/or GLENWOOD AS RESULT OF INJURY OR DEATH OCCURRING ON GLENWOOD AND ITS PROPERTIES INVOLVING VISITOR and/or VISITOR'S HORSE.

THE VISITOR UNDERSTANDS THAT THE INTENT OF THIS RELEASE AND HOLD HARMLESS AGREEMENT IS TO INDEMNIFY GLENWOOD FROM ANY CLAIM WHATSOEVER FROM VISITOR, HIS/HER FAMILY AND HEIRS, and/or A THIRD PARTY ARISING FROM VISITOR'S PRESENCE ON and/or USE OF GLENWOOD AND ITS PROPERTIES.

THIS MEANS GLENWOOD SHALL NOT BE LIABLE FOR ANY INJURY TO A VISITOR, VISITORS'S HORSE, FAMILY, GUESTS, INVITEES, AGENTS OR EMPLOYEES ACCOMPANYING VISITOR ONTO GLENWOOD'S PROPERTIES; AND VISITOR HEREBY AGREES TO INDEMNIFY, DEFEND, AND HOLD HARMLESS GLENWOOD FROM ANY AND ALL CLAIMS OR ASSERTIONS OF EVERY KIND AND NATURE RELATING TO VISITOR'S PRESENCE ON OR USE OF GLENWOOD AND ITS PROPERTIES BY VISITOR, VISITOR'S HORSE, FAMILY, GUESTS, INVITEES, AGENTS OR EMPLOYEES ACCOMPANYING VISITOR ONTO SAID PROPERTY.

THE UNDERSIGNED VISITOR WARRANTS THAT HE/SHE HAS READ THIS AGREEMENT IN IT'S ENTIRELY AND FULLY UNDERSTANDS THE CONSEQUENCES OF SIGNING THE AGREEMENT. THE AGREEMENT IS WRITTEN AS PLAINLY AS POSSIBLE TO ENSURE VISITOR'S COMPLETE UNDERSTANDING OF THE AGREEMENT. _____ (INITIAL)
