

Assumption of the Risk and Waiver of Liability

I hereby confirm that the Participant does not have an elevated temperature or otherwise exhibit any symptoms of COVID-19, is in good health and able to participate in the recreational activity. I acknowledge the activity may involve risk and danger of bodily injury or death, and I further acknowledge the contagious nature of COVID-19 and knowingly and voluntarily assume the risk that participation in the activity may result in exposure to, or infection by COVID-19, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I hereby assume the risk and responsibility for all dangers and risks associated with participating in the activity.

I hereby release, covenant not to sue, discharge, and hold harmless Maryland Dressage Association (MDA), and its elected/appointed officials, directors, volunteers, assigns of and from any claims, liabilities, actions, damages, costs or expenses of any kind arising out of or relating to participation in the activity by me or any of my minor children. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of Insightful Coaching with Trisha DeRosa clinic hosted by MDA, and their respective elected/appointed officials, employees, agents, representatives, successors and assigns with respect to the activity.

Waiver and release of liability: In conjunction with participating in this MDA event, I hereby release, waive and covenant not to sue and further agree to indemnify and hold harmless MDA for any reason. I agree to reimburse MDA for any and all attorney's fees and costs incurred by MDA in enforcing the terms of this agreement and/or in defending or prosecuting any claims involving or in any way relating to me.
