According to NEISS (National Electronic Injury Surveillance Systems of the United States Consumer Products) horse activities ran 64 <sup>th</sup> among the activities of people relative to injuries that result in a stay in U.S. hospitals. Related injuries can be severe requiring more hospital stays and resulting in more lasting residual effects than injuries in other activities. C.	Nature of Riding Horses
	RIDER UNDERSTANDS THAT: No horse is a completely safe horse. Regardless of a horse's training or past experience, a horse may, with or without warning or any apparent cause; buck, bolt, stumble, rear, kick, run, stop short, fall, bite, make unpredictable movements, spook, jump obstacles, step on a person's foot/feet, push or shove a person. Saddles, girths and/or bridles may loosen or break, all of which may cause Rider to fall or be jolted, resulting in property damage, personal injury, or death. Blue Goose Stable, LLC is not responsible for partial or total acts, occurrences, or elements of nature that can scare a horse or cause it fall or react in any unsafe way.

E.	Protective Equipment / Headgear Requirement

As a condition of riding any horse at BLUE GOOSE STABLE,LLC or any location Blue Goose Stable, LLC is hosting an event; Rider is REQUIRED to wear and utilize headgear that must meet or exceed ASTM (American Society for Testing & Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carry the SEI tag. The headgear and its harness must be secured, properly fitted and fastened at all times while mounting, riding, and dismounting horses. If Rider is in violation of this requirement at any time, Rider must immediately discontinue riding until such headgear is properly in place. Rider is to wear and utilize all protective clothing and equipment for the discipline in which they are riding. Footwear must be proper equestrian footwear with a heel and closed toes. Closed toe shoes that cover the whole foot are required by all persons on the facility grounds, at all times when working with or around the horse. Rider is responsible for ensuring all their spectators, grooms, and guests abide by this rule if they are within 6 feet of any horse. Initial
