Racine County Pony Club Combined Training (CT) and Eventing Derby General Information and Scoring:

All riders should arrive early enough to walk their courses. The jumping phase will run in the following order: Pre Starter Novice, Starter Novice, Beginner Novice, and Novice

All ride times are tentative. Organizers reserve the right to change ride times. Listen for announcements and check for Notices at Show Desk.

Post Entries: Entries received after the closing date will not be accepted.

Refunds: Before closing date, Derby entry will be refunded in full. After closing date, no refunds. Unless the event is cancelled by organizers.

Incomplete Entries/Changes: Incomplete entries will either be returned or charged a \$15.00 administrative fee. All entries must be complete by September 1st, 2020.

Competition Rules and Amendments:

This competition will be conducted under the rules and regulations contained herein and will conform to USEA/USEF rules as applicable and the following amendments:

The Dressage Phase (CT and Eventing Derby) will be scored on a penalty point basis; as in Eventing, the competitor with the lowest score will win that division of the competition.

- A. Reading of Tests: Reading of test will be permitted for the Ground Pole/Riding in the Open and Pre-Starter Novice division. A 2 point penalty will be applied to Starter Novice, Beginner Novice, and Novice divisions, if a reader is used and the test is not executed from memory.
- B. Show attire and Braiding: optional.
- C. Eliminations: Please refer to the current USEA/USEF Rules for Eventing.
- D. Errors or deviations from the prescribed course and for using a reader are penalized as follows:

a. First error
b. Second error
c. Third error
d. Reader Used for Starter Novice,
Beginner Novice, and Novice Divisions

The Jumping Phase General (CT and Derby)

A. Whenever horses are tied in the final classification, the horse with the least number of faults in the Jumping phase (Derby jumping phase is both Phase I Show Jumping and Phase 2 Cross County) shall be placed first. If still tied, the best score of the collective marks of the Dressage shall prevail. If still tied, placings and awards are to be duplicated.

Phase I Show Jumping (CT and Derby) rules and scoring will conform to the current USEA/USEF Rules for Show Jumping.

- A. Eliminations: Ground Poles and Pre Starter Novice riders may have their coach assist them in the unlikely event that they are eliminated. At the Judges' discretion, Ground Poles and Pre Starter Novice riders who have been eliminated may complete the course. Starter and Beginner Novice riders may, at the Judge's discretion, negotiate the obstacle(s) at which they were eliminated with the assistance of their coach if necessary.
- B. Jumping Phase Dress and Saddlery: USEA/USEF Rules for Cross-Country apply to Derby riders

and including protective vests, helmets with harness and USEA medical armbands. USEA regulations for safety equipment will be required. CT riders must have helmet with harness and riding boots (half chaps and paddock boots are also acceptable). No sleeveless shirts or tank tops are permitted for CT or Derby riders.

C. Errors or deviations from the prescribed course are penalized as follows for CT and Derby riders in the sand arena (all show jumping style jumps):

a. 1st/2nd/3rd Disobedience
 b. 4th Disobedience
 c. Knockdown
 d. 4 penalties
 4 penalties

d. 1st fall of competitor or horse Elimination

e. Error of course not rectified Elimination

D. During the CT competition all gates will be closed to the sand arena. During the Derby competition the east gate will be open and Derby riders will continue, without stopping, to the cross country portion of the competition.

Phase II Jumping Cross Country (XC) (Derby Only) rules, scoring, and dimensions of obstacles will be according to the USEA/USEF Rules for Eventing of the current year and as indicated on the class list.

- A. Eliminations: Ground Poles/Riding in the Open and Pre Starter Novice riders may have their coach assist them in the unlikely event that they are eliminated. At the Judges' discretion, Ground Poles/Riding in the Open and Pre Starter Novice riders who have been eliminated may complete the course. Starter and Beginner Novice riders may, at the Judge's discretion, negotiate the obstacle(s) at which they were eliminated with the assistance of their coach if necessary.
- B. Jumping Phase Dress and Saddlery: USEA/USEF Rules for Cross-Country apply, including protective vests, helmets with harness and USEA medical armbands. USEA regulations for safety equipment will be required.
- C. Errors or deviations from the prescribed course are penalized as follows:

a. 1st/2nd/3rd disobedience (different obstacles)
 b. 2nd disobedience (same obstacle)
 c. 3rd disobedience (same obstacle)
 d. 4th penalized disobedience on XC course
 e. First fall of competitor or horse
 f. Error of course not rectified

D. Ground Poles/Riding in the Open riders will leave the sand arena through the east gate. They will need to pass through a set of construction cones and then proceed to the finish line. Some liberties with the course will be given but riders will be given approximately two minutes of time to complete the course. Rules C.e and C.f from the above section will be applied to the Ground Poles/Riding in the Open horse and rider combinations.
