

RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT

This Release of Liability and Hold Harmless Agreement (“Agreement”), is made as of this _____ day of _____, 2____ between Copeland Farms, Inc, its officers, directors, shareholders, employees, and Liz Lund Eventing, LLC and their members, governors, officers, directors, agents, employees, volunteers, and any other person or entity acting on their behalf (hereinafter referred to collectively as “Host”) and the person(s) executing this document (hereinafter referred to as “Guest”).

GUEST ACKNOWLEDGES THAT THERE ARE INHERENT RISKS IN BEING ON OR AROUND HORSES. THOSE RISKS INCLUDE SERIOUS BODILY INJURY AND DEATH. GUEST UNDERSTANDS THAT THESE RISKS ARISE FROM THE FACT THAT ANY HORSE MAY ACT UNPREDICTABLY AND THAT ALL HORSES ARE CAPABLE OF SUDDEN, UNEXPECTED, AND POTENTIALLY DANGEROUS MOVEMENTS. GUEST APPRECIATES THAT ALL HORSES ARE EASILY FRIGHTENED BY SOUND; MOVEMENT; UNFAMILIAR OBJECTS, ODORS, AND PERSONS; OTHER ANIMALS INCLUDED BUT NOT LIMITED TO LIVESTOCK, NATURAL HAZARDS; AND ARTIFICIAL CONDITIONS AMONG OTHER THINGS AND MAY RUN, BOLT, BITE, BUCK, OR KICK WITH NO WARNING AS A RESULT. GUEST UNDERSTANDS THAT SERIOUS BODILY INJURY, PROPERTY DAMAGE, OR DEATH MAY RESULT WHILE PETTING, FEEDING, WATERING, BRUSHING, TACKING, SADDLING, MOUNTING, DISMOUNTING, SHOEING, VETTING, RIDING, OR OTHERWISE BEING ON OR AROUND ANY HORSE.

BY SIGNING THIS AGREEMENT, GUEST ACKNOWLEDGES THAT HE/SHE IS AWARE OF THE INHERENT RISKS OF BEING ON OR AROUND HORSES, APPRECIATES THAT THESE RISKS INCLUDE SERIOUS BODILY INJURY, PROPERTY DAMAGE, AND DEATH, BUT VOLUNTARILY CHOOSES TO ENCOUNTER THESE RISKS ANYWAY THEREBY ASSUMING ALL RESPONSIBILITY FOR ANY INJURY, DAMAGE, OR DEATH CAUSED TO GUEST AS A RESULT OF BEING ON OR AROUND HORSES AND LIVESTOCK.

In consideration for Host’s equine services and participating in – or observation of - its equine activities including but not limited to horse riding, trail riding, training, riding instruction, dressage, jumping, eventing, horse stabling, Guest hereby releases, waives, and forever discharges Host and other Guests of all actions of whatever kind arising from bodily injury, death, or property damage which relate in any way to Host’s equine related services and activities so long as such injury, property damage, or death is not caused by an intentional, willful, or wanton act or omission of Host or other Guests (*i.e.* Guest releases Host and other Guests from liability for damages caused by Host and other Guests’ negligent acts or omissions only). Guest further agrees to indemnify Host and other Guests for, and hold Host and other Guests harmless from, all judgments, claims, demands, attorney fees, and costs arising from any such action.

This release is given on behalf of Guest and Guest’s spouse, legal representatives, administrators, executors, heirs, and assigns, and in the case of any child or children of Guest’s, on behalf of

them and their legal representatives, administrators, executors, heirs, and assigns. This release is an ongoing release that does not expire and remains in effect until Guest has revoked it in a writing provided to Host.

GUEST ACKNOWLEDGES THAT HE/SHE HAS CAREFULLY READ THIS RELEASE, UNDERSTANDS THAT HE/SHE IS KNOWINGLY AND VOLUNTARILY ASSUMING ALL RISKS ASSOCIATED WITH BEING ON OR AROUND HORSES INCLUDING SERIOUS BODILY INJURY, DEATH, AND PROPERTY DAMAGE, AND RELEASES HOST AND OTHER GUESTS FROM ALL LIABILITY FOR BODILY INJURY, DEATH, OR PROPERTY DAMAGE RESULTING FROM HOST AND OTHER GUESTS' NEGLIGENCE AND SHALL INDEMNIFY AND HOLD HOST AND OTHER GUESTS HARMLESS FROM THE SAME.
